Main issues and lessons learned

The importance of having a defined plan of action and project proposal from each Pilot school before commencing any work or contract.

Meeting regularly face-to-face in DWEC / or in schools, or virtually for progress reports is imperative.

Offering of CPD is vital at all stages and the main lesson learned here is that the PDST, based in DWEC already had some expertise available to assist us in the project and indeed they have developed more CPDs and CPAs as a result.

Asking schools to digitally track the progress of their projects was an issue and indeed a lesson. The best solution was to ask for these at the meetings and define them in terms of lesson plans and exemplars for the final stages of the Project in 2022.
